## Notification regarding POST-GRADUATE MEDICAL/DENTAL State Quota seats counselling on the basis of NEET-PG/NEET MDS-2018 Result

Applications in prescribed format are being invited for the proposed counselling from NEET PG -2018/ NEET MDS - 2018 qualified eligible candidates who fulfill the following eligibility criteria:-

The candidates must have passed MBBS/BDS Examination from any University/Medical College of Jharkhand State.

Those candidates who are resident of Jharkhand, admitted in MBBS course in the Medical colleges of Bihar in the session started from 2000/creation of Jharkhand State or admitted in Medical colleges of Bihar before the creation of Jharkhand State and have passed MBBS may also apply as per Govt. of Jharkhand notification no. 9/vividh-13-05/2012 65 (9), Health/Ranchi, dated 07.05.2013. (They have to produce Local/Permanent residential certificate issued by D.C./S.D.O. (Civil) of Jharkhand State).

The candidates must have completed the Rotating Internship or likely to complete by 31 March, 2018. Reservation: - Up-to-date Reservation Policies/Rules of the Govt. of Jharkhand will be applicable. Certificate issued by anyone other than Sub Divisional Officer - (Civil) or Dy. Commissioner of Jharkhand State shall not be entertained and will lead to rejection of his/her claim. No other document in support of his/her claims for caste will be entertained. Caste certificate produced by BC-1&BC-II candidates will be valid only if he/she does not belong to creamy layer & it should be mentioned clearly in their caste certificates. The caste certificate format is available under Downloads column on the Board's official website.

Counselling will be held as per letter no. - 7(A) Namankan & 14-01-09/226 (7A) (dated 10.06.2011, sankalp no. 230(9) dated 22.12.15 and its amendment and sankalp no. 143(a) dated 06.04.2017 issued by Department of Health, Medical Education and Family Welfare, Govt. of Jharkhand.
